

By using our web site, applying for or opening an account with us, you consent to the collection and use of information as set forth in this Privacy Policy.

Like our products, Intuitivethot's Privacy Policy is simple and straightforward: We respect your privacy, and we are committed to protecting it.

We protect the confidentiality and security of your personal and financial information by placing you, our customer, in control of the process by allowing you to consent to any information sharing before it occurs. Intuitivethot is committed to these four Privacy Principles:

Principle 1. We collect only the information necessary to deliver the products and services you request.
